

## **GUIDELINES FOR OPENING A SECURITIES TRADING ACCOUNT FOR FOREIGN INVESTORS**

**Dear Valued Investors,**

SmartInvest Securities Corporation (AAS) would like to express our warmest greetings and sincere appreciation to you for choosing AAS to open your securities trading account.

Regarding the procedure for opening a securities trading account for foreign investors in Vietnam, we would like to provide you with the following information:

### **A. GENERAL INFORMATION**

Foreign institutional or individual investors must complete the required documentation before securities transaction in Vietnam, as outlined below:

- ✓ **Application for a Securities Trading Code (STC):** This unique code is issued by the Vietnam Securities Depository and Clearing Corporation (VSDC) for each foreign investor.
- ✓ **Opening a securities trading account** with a depository member Securities Company
- ✓ **Opening an Indirect Investment Capital Account (IICA)** in Vietnamese Dong at only one commercial bank or a branch of a foreign bank authorized to conduct foreign exchange business in Vietnam.

- **Notarized Copy (\*):** Must be notarized in the investor's home country according to local laws/ Notarized at a notary office in Vietnam/ notarized and legalized by the Vietnamese consulate.
- Foreign investors must comply with regulations on foreign ownership when trading stocks on the Vietnamese securities market.
